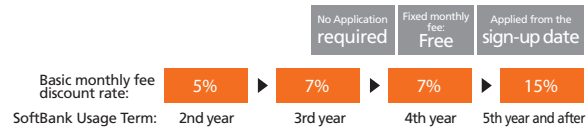

- If another member of the family who is not part of the contract is to pay the bill, the consent of the person is required.
- The customer to whom the monthly bill is mailed is responsible for paying the bill. However, if the lump sum payment for all lines is requested and the bill is mailed to another address, the customer is still responsible for paying their share of the bill.
- If the customer paying the bill in a lump sum including the amount of sub-lines subscribes to Itemized Call Charge Statement service, the statements of all lines will be sent to the customer.
- If the total payment for all lines in a lump sum payment is not made by the due date, the services of all lines under the contract will be suspended after a notification of the unpaid bill.
